HEREBY RELEASES, WAIVES, DISCHARGES, AND COVENANTS NOT TO SUE HAVILAH DANCE COMPANY, THE EAGLES' WINGS STUDIO BOARD OF DIRECTORS, ITS INDIVIDUAL MEMBERS, DIRECTORS, AND VOLUNTEERS (HEREINAFTER REFERRED TO AS "RELEASEES"), SUCH RELEASE AND WAIVER TO BE FROM ALL LIABILITY FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFOR ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE PROGRAMS, REHEARSALS, PERFORMANCES, AND RELATED ACTIVITIES OF EAGLES' WINGS STUDIO.

2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releasees and each of them FROM ANY LOSS, LIABILITY, DAMAGE, OR COST they may incur arising out of or related to the UNDERSIGNED'S INJURY OR DEATH, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

3. HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE arising out of or related to the programs, rehearsals, performances, and related activities of EAGLES' WINGS STUDIO, whether caused by the NEGLIGENCE OF RELEASEES or otherwise.

HEREBY agrees that this Release and Waiver of Liability extends to all acts of negligence by the Releasees and is intended to be as broad and inclusive as is permitted by the laws of the State of North Carolina and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
